The Criteria for Selection

To be included on the World Heritage List, sites must be of outstanding universal value and meet at least one out of ten selection criteria.

These criteria are explained in the Operational Guidelines for the Implementation of the World Heritage Convention which, besides the text of the Convention, is the main working tool on World Heritage. The criteria are regularly revised by the Committee to reflect the evolution of the World Heritage concept itself.

Until the end of 2004, World Heritage sites were selected on the basis of six cultural and four natural criteria. With the adoption of the revised Operational Guidelines for the Implementation of the World Heritage Convention, only one set of ten criteria exists.

Selection criteria

(i)

to represent a masterpiece of human creative genius;

(ii)

to exhibit an important interchange of human values, over a span of

or within a cultural area of the world, on developments in architecture technology, monumental arts, town-planning or landscape design

(iii)

to bear a unique or at least exceptional testimony to a cultural tradition to a civilization which is living or which has disappeared;

(iv)

to be an outstanding example of a type of building, architectural of technological ensemble or landscape which illustrates (a) significating stage(s) in human history;

(v)

to be an outstanding example of a traditional human settlement, landor sea-use which is representative of a culture (or cultures), or hum interaction with the environment especially when it has become vulnerable under the impact of irreversible change;

(vi)

to be directly or tangibly associated with events or living traditions, videas, or with beliefs, with artistic and literary works of outstanding universal significance. (The Committee considers that this criterion shapeferably be used in conjunction with other criteria);

(vii)

to contain superlative natural phenomena or areas of exceptional nat beauty and aesthetic importance;

(viii)

to be outstanding examples representing major stages of earth's hist including the record of life, significant on-going geological processes the development of landforms, or significant geomorphic or physiografeatures;

(ix)

to be outstanding examples representing significant on-going ecolog and biological processes in the evolution and development of terrest fresh water, coastal and marine ecosystems and communities of pla and animals;

(x)

to contain the most important and significant natural habitats for in-sconservation of biological diversity, including those containing threate species of outstanding universal value from the point of view of science conservation.

The protection, management, authenticity and integrity of properties are also important considerations. Since 1992 significant interactions between people and the natural environment have been recognized as **cultural** landscapes.
